- Form: #1 Mandatory each year, in accordance to ESDCAR Bylaws, Article VI, Section 11.
- Form: #2 Must be updated each year by the REALTOR® Designated Broker, plus any changes throughout the year shall be reported to the Association office immediately, according to Association Policy and Procedures.
- Form: #3 Although ESDCAR does very little communications by fax anymore, our fax communications with you are affected by the FCC's regulation because of its very broad definition of an "unsolicited advertisement," which includes "any material advertising the commercial availability or quality of any property, goods or services." The FCC indicates that this definition includes notices about upcoming conferences and seminars, membership renewals, new product announcements, etc. As you know, we oftentimes use fax communications to inform you of important offerings that may be of interest to you or that may affect your membership.

The bottom line is that we will no longer be able to send you any fax that may contain advertisements of our benefits offerings, products or services, unless you give us permission to do so by completing and returning the attached form. Please note that the form also contains permission to send e-mails, direct mail and telephone calls containing advertising, in anticipation of the FCC's next ruling, which may limit the e-mails that we can send to you.

We apologize for this inconvenience and thank you for helping us comply with the Federal regulation.

Please complete all of the above mentioned forms if you are the Designated REALTOR® member listed with ESDCAR and return by the method that is most convenient for you i.e., fax and or US mail as indicated on the forms. (All other non-REALTOR® members are to complete forms #1 & #3 as requested)
